#### How to use

Remove rust and dirt.

The ground has to be clean, dry and free from fat.

Cover areas not to be painted.

Apply a white primer, e.g. DUPLI-COLOR Primer white. (Not if used on polystyrene!)

Before use, shake can for 3 minutes.

Test spray at an invisible spot.

Spray from a distance of 12-15 cm several thin coats.

Do not spray over surfaces which are painted with synthetic resin lacquer!
